1. General Information

Wyckoff Country Club is a private membership club offering a range of amenities, including an 18-hole golf course, dining facilities, event spaces, and member-exclusive events. All members are expected to conduct themselves in accordance with the standards set forth in this handbook.

2. Member Code of Conduct

All members and their guests are expected to:

- Treat staff, fellow members, and guests with courtesy and respect.
- Refrain from discriminatory, harassing, or abusive language or behavior.
- Follow all club rules, policies, and posted signs.
- Adhere to instructions given by staff and management.

- Avoid behavior that disrupts the enjoyment of the club for others.
- Consume alcohol responsibly; intoxicated behavior will not be tolerated.
- Refrain from illegal drug use or possession on club property.
- Use facilities responsibly and report any damage.
- Comply with all applicable local, state, and federal laws.

Prohibited Conduct Includes (but is not limited to):

- Verbal or physical abuse toward staff, members, or guests.
- Harassment, intimidation, or discrimination of any kind.
- Property damage or vandalism.
- Disorderly conduct, including fighting or obscene gestures.
- Excessive intoxication or public drunkenness.
- Falsifying scores or cheating in club events.
- Unauthorized commercial activity or solicitation.
- Misuse of the Club's name or logo without permission.
- Failure to follow staff instructions or club rules.

Members are responsible for the behavior of their guests and may face consequences for their guests' misconduct.

3. Dress Code

Proper attire is required throughout the Club.

- **Golf Course:** Collared shirts, golf slacks or shorts. No denim, tank tops, or athletic shorts.
- **Dining Areas:** Smart casual attire. No ripped clothing, swimsuits, or hats.
- **Club Events:** Attire may vary based on event (e.g., cocktail attire, business casual).

4. Guest Policy

- Members are responsible for the behavior of their guests.
- Guests must comply with all Club rules and policies.
- Members are accountable for ensuring all applicable guest fees are paid.

5. Golf Course Rules & Cart Policy

Golf Course Rules

- Tee times must be reserved in advance.
- Players must check in prior to play.
- Maintain proper pace of play (4-hour maximum for 18 holes).
- Replace divots and repair ball marks.

Cart Usage Policy

To ensure fairness and proper course maintenance:

Cart Fees

- Each member is responsible for paying their own cart fee.
- Guests must pay applicable greens and cart fees.
- Cart fees are charged per player, not per cart.

Sharing or Unauthorized Use

- Allowing another member or guest to ride/play without paying is prohibited.
- Violations may result in suspension of privileges and/or additional charges.

Cart Operation

- Carts must remain on paths near greens and tees where posted.
- Only licensed drivers may operate carts.
- Two players maximum per cart.
- Members are responsible for damage caused by misuse.
- All cart keys must be returned to the Pro Shop after use. Members may not retain keys.

Enforcement

- Staff may verify cart use and fee compliance at any time.
- Non-compliance may result in additional charges or suspension of privileges.

6. Dining & Event Guidelines

- Reservations are encouraged for dining and events.
- Members may be held responsible for no-shows or late cancellations, when applicable.
- Special events may carry event-specific rules and cancellation policies.

7. Tee Time Booking & Cancellation Policy

- **Booking:** Members may reserve tee times up to 7 days in advance.
- **Cancellations:** Must be made at least 24 hours in advance to avoid penalty.
- **No-Shows:** Daily rate will be charged to the credit card on file.

- **Late Arrivals:** May forfeit reserved time; play will depend on course availability.
 - **Weather Exceptions:** No fees apply for cancellations due to course closure or inclement weather.

8. Member Photo Consent

- Member photos are required for internal records, security, and identification.
 - Photos are confidential and will not be shared publicly without written consent.
 - Members may update their photo by contacting the Pro Shop or Membership Office.
 - By maintaining membership, members agree to this requirement.

9. Disciplinary Procedures

Violations of the Code of Conduct or Club policies may result in:

- Verbal or written warning.
 - Probation.
 - Suspension of privileges.
 - Termination of membership.
